

It's as easy as 1 - 2 - 3!

1. Check for injuries.

If the driver is injured, you are not required to move the vehicle. Call 9-1-1.

2. Move it!

If there are NO injuries to the driver and the vehicle is operable, you **MUST** move the vehicle off the highway to a shoulder or parking area.

3. Report the crash.

Notify the appropriate authorities, if required, as stated in ORS 811.720. Exchange information with the others involved. Download the "Oregon Traffic Accident and Insurance Report" form to easily and quickly file your crash information, www.OregonDMV.com.



What is Oregon's "Move It" Law?

ORS 811.717 states the following:

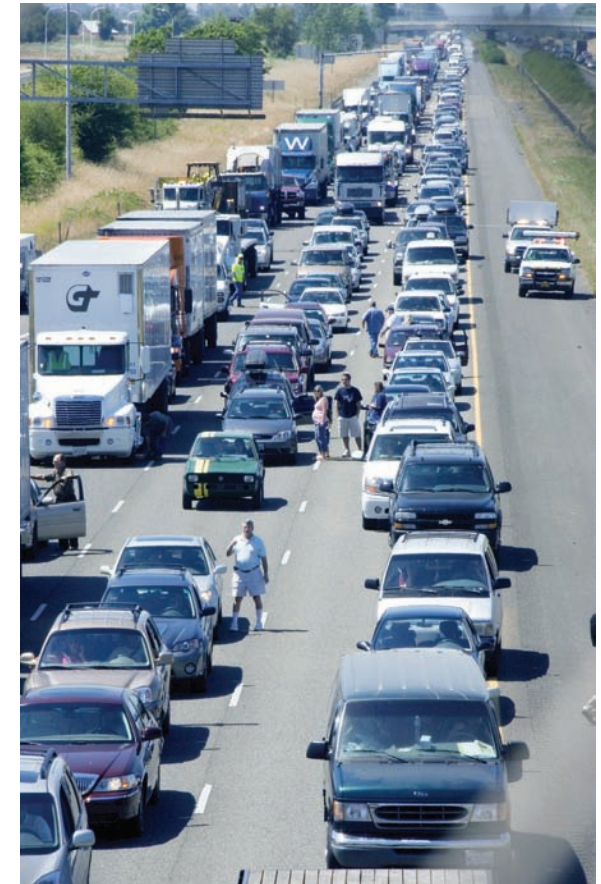
1. The driver of a motor vehicle commits the offense of failure to remove a motor vehicle from the highway if, after an accident:
 - a. The driver has not suffered any apparent personal injury;
 - b. The motor vehicle is operable and does not require towing;
 - c. It is safe to drive the motor vehicle to a designated parking area along the highway or shoulder of the highway; and
 - d. The driver does not move the motor vehicle to a designated parking area along the highway or shoulder of the highway.
2. The offense described in this section, failure to remove a motor vehicle from the highway, is a Class C traffic violation (2007 c.664.4)

Know before you go!
Dial 5-1-1 for the latest road conditions, traffic reports and more.

Involved in a crash? If the driver is not injured, it's not necessary to wait for law enforcement before moving vehicles.

In fact, Oregon law requires you to move your vehicle from the highway in a non-injury crash if your vehicle is operable and it is safe to move it. Then you can exchange information with others involved and witnesses. Keep this brochure in your vehicle, and if you find yourself involved in a crash, use the cards in this brochure to collect the important details.



By moving your vehicle safely off the highway, you will...

- Increase your personal safety and that of others around you
- Reduce the time it takes to clear the crash
- Reduce the chance of a secondary crash
- Increase the safety of emergency crews
- Reduce delay and congestion

1. Check for injuries.
2. If the driver is uninjured, and the car is operable, move it out of the travel lanes and onto the highway shoulder or parking area.
3. Report the crash if required.
